## **TERMS AND CONDITION APPLICATION AND PAYMENT 2025**

### **APPLICATION TERMS:**

1. Pre-approval will be done by WhatsApp and thereafter the application will be send.
2. All applications must be scanned after completion in full and returned by WhatsApp or email. No photos will be accepted.
3. The COA used by Madibeng for food and deli vendors must be returned with the application. Only products approved on the application are allowed.
4. Vendors must be available to attend both days and be able to set up on Thursday or early Friday morning.
5. A 50% deposit of full payment must be done immediately after approval. Failure to comply will result in cancelation of your stand without a refund. All stall fees must be paid in full by 18 July 2025.
6. **NO REFUNDS** will be done if the vendor does not show up at the event, or if the vendor cancels the stall for any reason whatsoever after payment.
7. A vendor must wear his entrance band at all times, if you are found without an entrance band you must pay the entrance fee or leave the premises immediately.

### **PARKING ARRANGEMENTS:**

1. Vendors will be allowed to enter with their vehicles to off-load only at the times specified.
2. **No** caravans allowed on/in the vendor area.
3. **NO** vehicles will be allowed to be part of the stand. Immediately after offloading, the vehicle must be removed and parked in the designated parking area prior to the start of the event.
4. **NO** vendor is allowed to bring a vehicle in before the safety officer give his permission at the end of each day.
5. Each vendor will receive an entrance sticker. **No** vehicle will be allowed inside the premises without this sticker. A vehicle without a sticker will be removed from the premises and a fine of R1500.00 will be applicable.
6. **VENDORS PARK THEIR VEHICLE AT THEIR OWN RISK.**

### **YOUR STALL:**

1. You provide your own tables, table cloths, gazebo, extension, lights and chairs.
2. Leave no trace .....keep your stall space clean and hygienic at all times.
3. Please don't smoke in your stall. Please pick up your cigarette butts when and where you smoke.
4. Vendors are not allowed to share any part of their stand without written consent.
5. No roaming with your products are allowed outside your stall area.
6. No banner, teardrop or other advertising material are allowed outside your stall boundaries and cannot obstruct access to fellow vendors.
7. ELECTRICITY: You don't pay for electricity and therefore must make your own provision if the festival's generator fails or break down. Everyone will have access to the generator for lights.

### **YOUR ATTITUDE:**

1. Be kind and courteous to your fellow vendors, the public and the organisers. Prejudice, disrespect, gossiping, negativity and a bad attitude will not be tolerated. It will result in the removal from the venue without a refund.
2. The organising committee will not take part in any discussion after the event regarding poor sales or feet or any negativity.
3. We as the organisers of the Strawberry Music festival cannot assure the feet at the festival, nor make any projections as we are in the hands of the public. It is also impossible to guarantee vendor sales. It is the risk that every vendor takes and if you are not prepared to take the risk, please do not participate in the event. More than one vendor will be approved for the same product.
